Typical Service

These strainers are used exclusively to prevent clogging in fire service systems. Such systems can include automatic water sprinklers and various spray systems.

Features

- Extra large baskets have an Open Area Ratio of at least 7 to 1. AWWA only requires a minimum of 4 to 1 Ratio.
- Extra large capacity baskets equal very low pressure drop and long intervals between cleaning and servicing, essential in this service.
- NPT tapped blow-off and vent connections are standard. Blow-off is at "D" for draining and cleaning, air vent is at "E". See next page for locations and sizes. Plugs are furnished as standard.

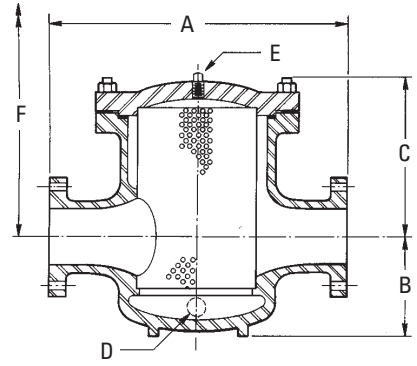
